

## Trustee Honoraria (December 1, 2014 to November 30, 2018)

Trustee honoraria are calculated in accordance with Ontario Regulation 357/06 and Trustee Honoraria Policy I-35 and includes:

1. Base Amount of \$5,900.00,
2. Enrolment Amount is based on the prior year Budget Estimates enrollment (submitted to the Board in June) multiplied by a factor of \$1.75,
3. Attendance Amount of \$50.00 per eligible committee meeting (optional amount which the HCDSB does not pay),
4. Distance Amount based on the geographic size of the Board's jurisdiction or for travel over 200 km one way (N/A).

The Halton Catholic District School Board (HCDSB) trustee honoraria for the period December 1, 2014 to November 30, 2018 includes the base amount and the enrolment amount only.
